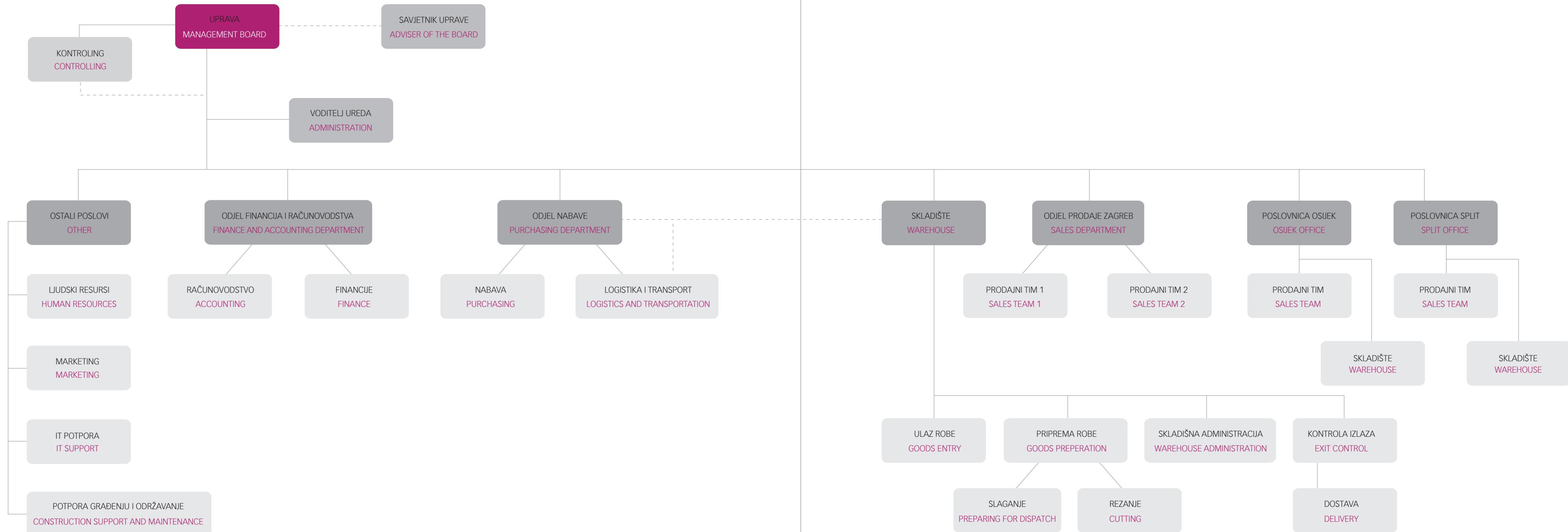

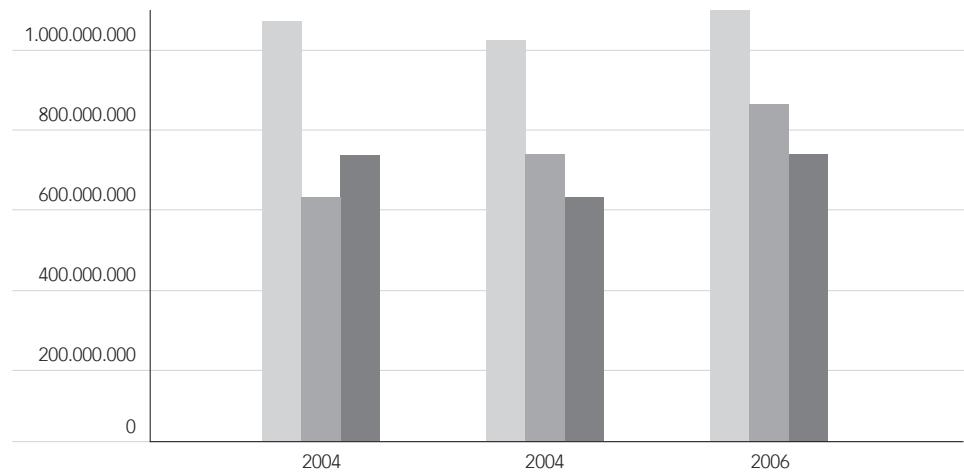
Proizvođači, trgovci, veletrgovci, instalateri i krajnji korisnici u 2007. su godini konzumirali 1,2 milijarde kuna raznih grupa i tipova kabela i vodiča.

Glavni i najvažniji subjekti na tržištu osim Tim Kabela su proizvođači kabela i vodiča. To su Elka Kabel d.d. i Eurocable Group d.d., koji godišnje proizvedu kabela u vrijednosti 1,1 milijarde kuna. Od proizvedenih kabela navedeni proizvođači izvezu čak 65% od godišnje proizvodnje, tako da se nedostatak kabela na tržištu uvozi.

Tim Kabel d.o.o. je kao najveći veletrgovac kabelima treći najvažniji subjekt na tržištu kabela, a uz navedene proizvođače ujedno i najveći uvoznik kabela i vodiča. Istraživanje tržišta pokazalo je da u zadnje tri godine jedino uvoz ima formiran trend konstantnog porasta, dok proizvodnja i izvoz variraju ovisno o raznim pokazateljima.

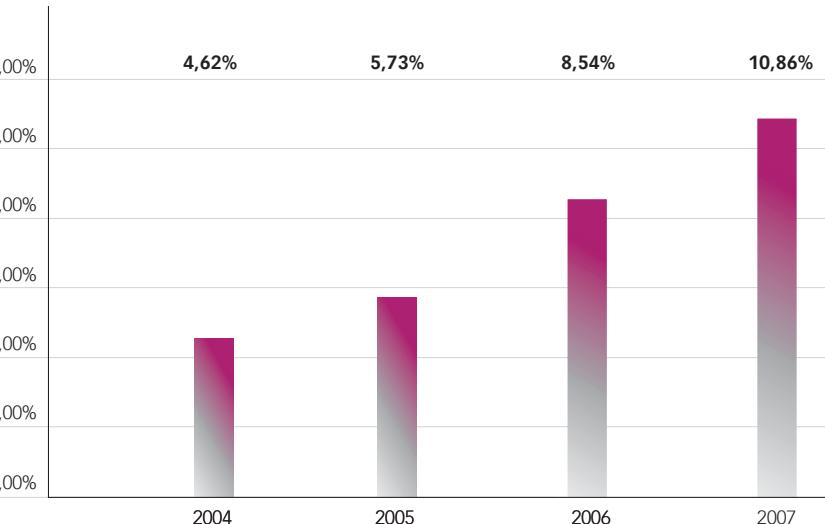

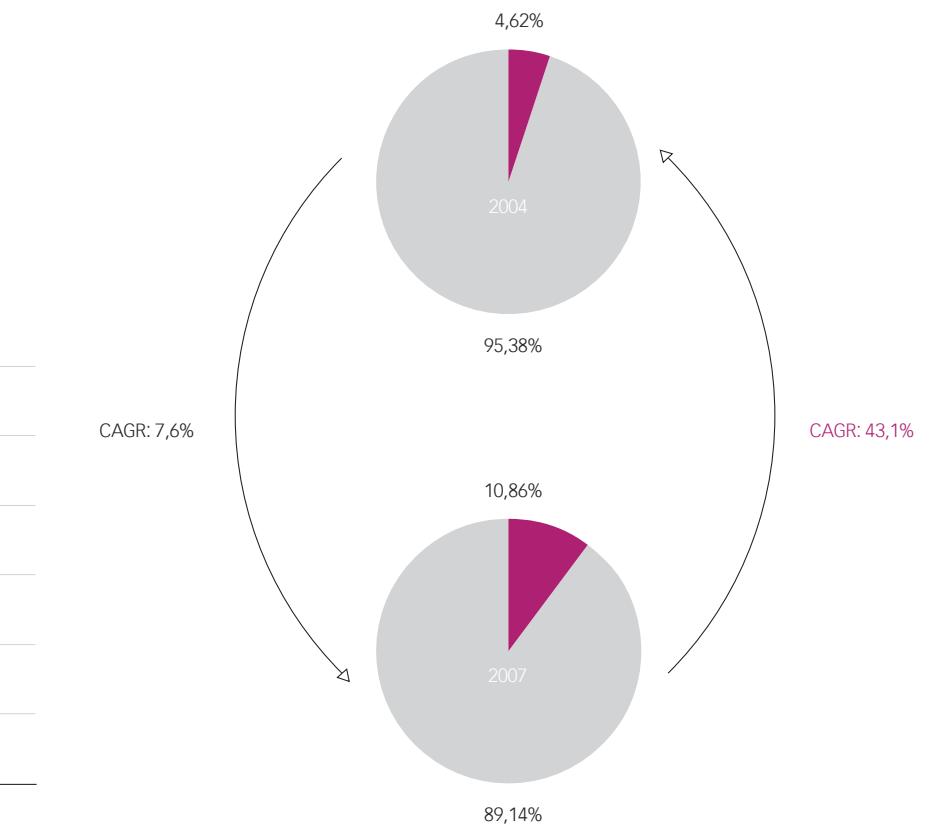
Rast tržišnog udjela Tim Kabela / Growth of Tim Kabel's market share

Tim Kabel u regiji

Razvojem društva i širenjem na regionalno tržište Tim Kabel jasno naglašava ozbiljnost u ispunjenju vizije da bude vodeći distributer kabela i vodiča u regiji. Tržišta Srbije, Bosne i Hercegovine te ostalih zemalja koje čekaju nastavak tranzicije i izgradnje infrastrukture velik su izazov i cilj Tim Kabela.

Tim Kabel in the Region

Through the company's development and expanding to the regional market, Tim Kabel clearly emphasises the serious intention to fulfil the vision and to be the leading distributor of cables and conductors in the region. The market of Serbia, Bosnia and Herzegovina and of other countries expecting the continued transition and construction of the infrastructure are a big challenge for Tim Kabel.



Utjecaj cijene bakra na poslovanje

Na poslovanje Tim Kabela u određenoj mjeri utječe kretanje cijena bakra na tržištu. Vrijednost bakra u kabelima u odnosu na druge materijale je značajna. Zbog našeg širokog assortimenta i velike količine kabela na skladištu, s manjim ili većim obrtajem, značajne količine bakra koje stoe na skladištu uzrokuju i vrlo promjenjivu tržišnu vrijednost kabela u zalihamama. U takvoj situaciji moramo dobro poznavati posljedice rasta i pada cijena bakra i biti dobro pripremljeni za različite situacije. Iz godine u godinu, zbog sve veće potražnje, cijena bakra je u konstantnom porastu, uz manje kratkoročne padove. Najvažnije mjesto za trgovinu ovim metalom je londonska burza London Metal Exchange (LME), koja je tijekom 2007. godine ostvarivala promet od preko 10 milijardi USD dnevno, s ukupnom vrijednosti ugovora tijekom 2007. od 2.000 milijardi USD. Procjenjuje se da će volumen trgovine biti udvostručen u idućih 3-5 godina. Osnovni pokretač ovakvog rasta je razvoj globalne ekonomije, koji je utjecao na snažni porast potražnje za industrijskim metalima. Industrijski metali koriste se za razvoj i obnovu svjetske fizičke infrastrukture i integralni su dio

proizvoda i strojeva koji pokreću globalni razvoj. U ove metale ubrajaju se bakar, cink, nikal, olovo i aluminij. S obzirom da su rezerve industrijskih metala ograničene, cijene imaju stalni trend rasta. Investitori u metale odnosno u dionice kompanija koje se bave eksplotacijom ovih metala višestruko su nagradeni tijekom proteklih godina. U svojoj bazi LME prati više od 400 skladišta, koja osiguravaju potrebne podatke o veličini i raspolaživosti trenutnih zaliha metala koji se prezentiraju investitorima te svima koji se u svom poslovanju susreću s industrijskim metalima. Potrebno je napomenuti da se vrlo mali postotak sklopljениh ugovora na burzi zaista realizira u smislu isporuke. Tijekom proteklih nekoliko godina najveći svjetski potrošač bakra je Kina, sa svojim snažno rastućim gospodarstvom. Također, veliki utjecaj na kretanje cijene bakra imaju i gospodarstva Indije i SAD, također velikih potrošača bakra. Iz priloženih tablica vidljiv je trend porasta cijene iz godine u godinu, što odgovara povećanju potražnje za ovim metalom.

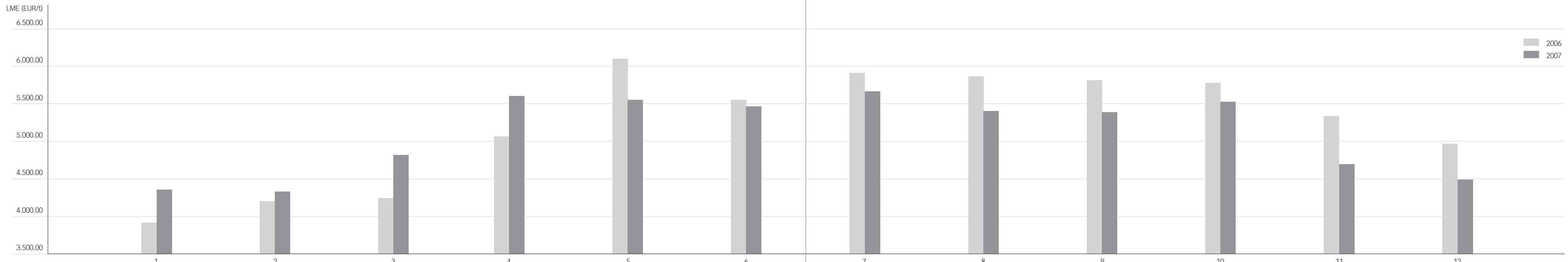
Copper Price Effect on the Operations



The operations of Tim Kabel are to a certain degree influenced by the copper price trend in the market. The value of copper in cables, in relation to other materials, is significant. Due to our wide assortment and a big quantity of cables in stock, with smaller or larger turnover, the significant quantities of copper that are in stock cause also very changeable value of the cables in stock. In such situation, we must know also the consequences of the growth and fall of copper prices and be well-prepared for various situations. Copper price is from year to year, due to ever larger demand in a permanent growth, with smaller short-term falls. The most important place for the trade in this metal is the London Metal Exchange to have realised during the year of 2007 the turnover of more than USD 10 billion per day, and the total value of the contracts of USD 2.000 billion during 2007. The volume of the trade is expected to double in the next 3-5 years. The basic mover of such a growth is the development of global economy, which influence on the strong increase in demand for industrial metals. Industrial metals are used for the development and rehabilitation of the world physical infrastructure and they are the integral part of the production of machines that

initiate the global development. Copper, zinc, nickel, lead and aluminium belong to those metals. As the reserves of industrial metals are limited, the prices have a permanent growing trend. The investors into metals or into the shares of the companies dealing with the exploitation of those metals are multiply rewarded during the past years. In its base the LME follows up more than 400 warehouses, which provide for the necessary data concerning size and availability of the current stocks of metals to be presented to the investors and to those confronted with industrial metals in their operations. It is to mention that a very small percentage of concluded contracts at the Exchange is actually realised with respect to a delivery. During the past several years, the biggest world consumer of copper is China with a power growing economy. The economies of India and USA have also great influence on the copper price trend, as well as big copper consumers. The price growing trend from a year to a year can be seen from the enclosed tables, what corresponds to the increase of the demand for this metal.

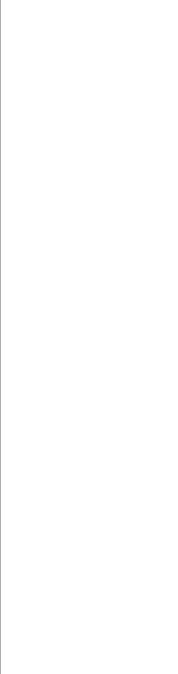
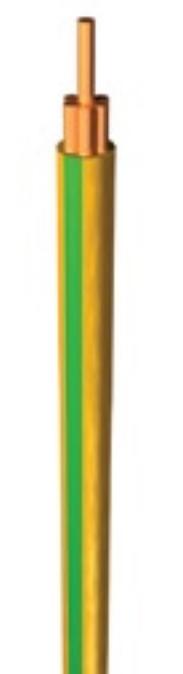

Izvještaj uspjeha

Poštovani partneri,

nadamo se da smo i tijekom 2007. godine uspjeli ispuniti Vaša očekivanja. Želimo Vam stoga iznijeti kratki pregled naših finansijskih rezultata kako biste dobili bolji uvid u poslovanje Tim Kabel kao Vašeg pouzdanog partnera.

S aspekta uspješnosti društva možemo zaključiti da su u odnosu na prethodnu godinu prihodi društva Tim Kabel rasli za 34,94% uz povećanje neto dobiti 23,68%. Prihodi od prodaje čine 99,52% ukupnih prihoda društva što pokazuje da je jedini cilj društva *core business*, a to je prodaja kabela i vodiča. U odnosu na prihode rashodi su rasli nešto bržim tempom, i to za 2,74%. Kamate po kreditu za kupnju zemljišta reflektiraju se kroz povećanje finansijskih rashoda (+94,42%, +1,4M), dok su ostali poslovni rashodi rasli zbog naknadno odobrenih bonusa našim najboljim kupcima/partnerima i povećanim izdacima - ulaganjem za usavršavanje naših zaposlenika (+89,18%, +1,1M). Povećana amortizacija (+43,20%, +860T) rezultat je ulaganja u poslovni objekt u Savskoj cesti dok je trošak zaposlenih porastao zbog osnaživanja našeg tima novim stručnjacima u drugoj polovici godine (+34,16%, +1,85M). Novim zapošljavanjem i dalje ostvarujemo veće prihode i dobit po broju zaposlenih. Smanjenje bruto marže sa 18% na 17% rezultat je povećanih finansijskih rashoda, točnije kamata po dugoročnom kreditu, kojima je početkom godine financirana kupnja atraktivnog zemljišta u Radničkoj cesti. Unatoč tome

društvo je operativno poslovalo bolje i povećalo operativnu dobit (EBIT) za 27,15%. U 2007. ostvarena je operativna dobit od 32,7 milijuna HRK.

Radni kapital društva povećan je sa 28,4 na 60,6 milijuna HRK, što iznosi 113,41%. Knjigovodstvena vrijednost društva u 2007. godini porasla je za 31,4% i iznosi 68,59 milijuna HRK (52,5% pasive). I dalje smanjujemo kratkoročnu zaduženost kod banaka i dobavljača, dok radni kapital financiramo na najbolji način iz dugoročnih izvora, tj. zadržane dobiti. Lager smo povećali za 18,23% novim assortimanom i u tom dijelu s odjelom nabave nastojimo maksimalno optimizirati lager i prilagoditi ga potrebama naših kupaca. Budući da je u drugoj polovici godine nastupio turbulentan period na svjetskoj finansijskoj sceni, pa i u Republici Hrvatskoj, likvidnost tržišta je narušena te je time naplata potraživanja postala naš novi fokus. Maksimalno smo se posvetili toj temi gdje nastojimo zadovoljiti potrebe naših kupaca i ujedno biti efikasni u naplati. I u ovakvoj situaciji narušene likvidnosti pokazujemo našu profesionalnost u poslu, gdje naše obveze prema dobavljačima uredno izvršavamo. Kapitalno ulaganje u prije spomenuto zemljište uzrok je smanjenju tokova novca u 2007. godini. I dalje planiramo investirati u kapitalne investicije kojima ćemo još više doprinijeti kvaliteti usluge, jačanju branda, boljem tržišnom položaju i ostvarivanju još boljih poslovnih rezultata!

Report of Success

Dear Partners,

We hope to have succeeded in fulfilling your expectations during 2007. We would therefore like to present you the summary of our financial results in order to give you a better insight into the operations of Tim Kabel as your reliable partner.

From the point of view of our Company's success, we can conclude that in relation to the previous year, the income of the company of Tim Kabel was growing by 34.94% with the increase of net profit by 23.68%. The revenue from sales represents 99.52% of the total income of the Company what indicates that our "core business" i.e. the sales of cables and conductors is the only objective of the Company. In relation to the income, the expenses were growing at somewhat faster rate i.e. by 2.74%. The interest on the credit for land purchase are reflected through the increase of financial charges (+94.42%, +1.4M), while the other operating charges increased due to subsequently granted bonuses to our best customers/partners and the increased expenses-investments for the upgrading of our employees (+89.18%, +1.1M). Increased depreciation (+43.20%, +860T) is the result of investing into the Office building in Savska Cesta while the cost of staff increased due to the strengthening of our team by means of new professionals in the second half of the year (+34.16%, +1.85M). With the new employing, we further achieve larger income and profit at the number of employees. The reduction of the gross margin from 18% to 17% is the result of the increased financial charges, to put it more precisely, the interest for the long-term credit by means of which we financed the purchase

of an attractive land plot in Radnička Cesta. In spite of that the Company was operatively better and increased the operating profit (EBIT) by 27.15%. In 2007, the operating profit of was realised at the amount of 32.7 million HRK.

The working capital of the Company has been increased from 28.4 to 60.6 million HRK what amounts in terms of percentage to 113.41%. The book value of the Company in 2007 increased by 31.4% and it amounts to 68.59 million HRK (52.5% of liabilities). We further reduce short-term borrowing with banks and suppliers while working capital is financed in the best way from the long-term sources i.e. retained profit. The stocks have been increased by 18.23% with new assortment and at that part we try, together with purchase department, to maximally optimise the stocks and adjust them to the needs of our customers. As in the other half of the year a turbulent period appeared at the world financial scene and in the Republic of Croatia too, the solvency of the market was spoiled and with it, the collection of receivables became our new focus. We paid maximum attention to that issue where we try to meet the needs of our customers and be also efficient with debt collecting. Even in such a situation of disturbed solvency, we show our professional attitude with the work where we fulfil orderly our liabilities to the suppliers. Capital investment into the previously mentioned land is the cause of the reduced cash flows in the year of 2007. We further plan to invest into capital investments by means of what we shall contribute even more to the quality of services, strengthening the brand and improving the position in the market; realising better business results.

Istraživanje zadovoljstva potrošača

Tim Kabel je, u suradnji s agencijom Puls, proveo anketno istraživanje zadovoljstva kupaca strukturiranim upitnikom "Licem-u-lice". Ciljevi istraživanja bili su: 1.) Utvrditi razinu zadovoljstva klijenata Tim Kabela; 2.) Usporediti razine zadovoljstva Tim Kabelom i drugim veletrgovcima kabela i vodiča; 3.) Ustanoviti komparativne prednosti i nedostatke Tim Kabelovog pružanja usluga u odnosu na glavne konkurente. Anketiranje je provedeno krajem 2007. godine, i to s obzirom na Tim Kabelovu regionalnu podjelu (Zagreb, Osijek, Split), a ispitani su bile tvrtke djelatnosti relevantne Tim Kabelu, unutar kojih su anketirane osobe odgovorne za nabavu kabela i vodiča u ime svojih poduzeća.

Customer Satisfaction Research

Tim Kabel implemented, in cooperation with Puls Agency, a poll-survey on customer satisfaction by means of a structural "Face-to-Face" questionnaire. The objectives of the research were: 1) to establish the satisfaction level of the clients of Tim Kabel, 2) to compare the levels of satisfaction with Tim Kabel with those with the other wholesalers of cables and conductors, 3) to ascertain comparative advantages and shortcomings of the services rendered by Tim Kabel in relation with those, by the main competitors. Poll survey was carried out by the end of 2007, taking into consideration the regional division of Tim Kabel regional division (Zagreb, Osijek, Split), and the respondents were the Tim Kabel relevant companies, within which the persons responsible for cable and conductors procurement were surveyed in the name of their enterprises.

The largest level of satisfaction was expressed by the respondents just with Tim Kabel (Graph 1). The respondents expressed great satisfaction with the specific

points of reference of satisfaction (Graph 2), as well as with the important segments of operations of Tim Kabel - the characteristics of the staff (Graph 3), the characteristics of the process of goods ordering and deliveries (Graph 4), and the products (Graph 5).

The carried out research showed the following:

- Tim Kabel is a premium quality supplier.
- Tim Kabel has been rated as the best supplier in the main operating aspects: business staff, process of goods ordering and deliveries, business policy, invoicing and the products.
- The main comparative advantages of Tim Kabel are quick services and a wide assortment.

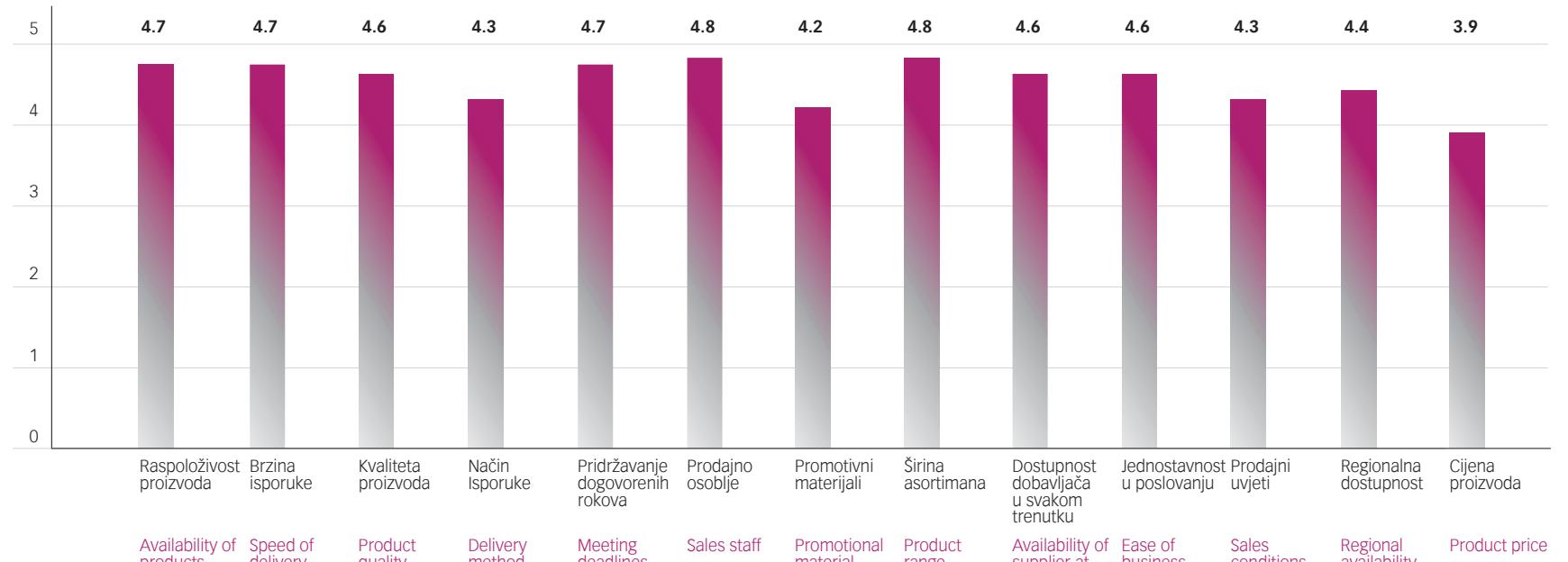

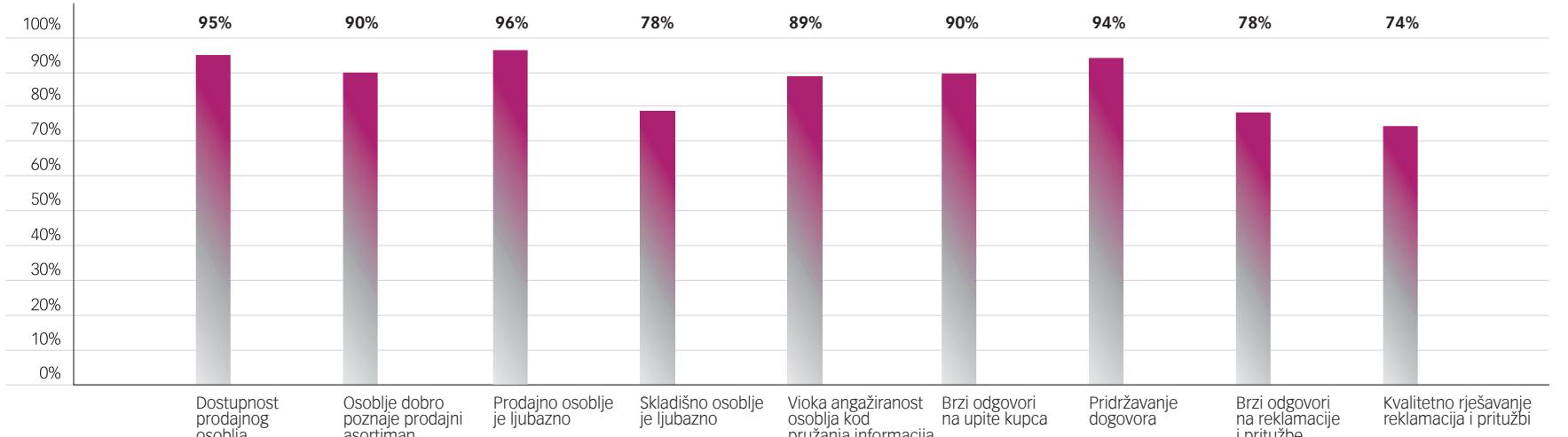

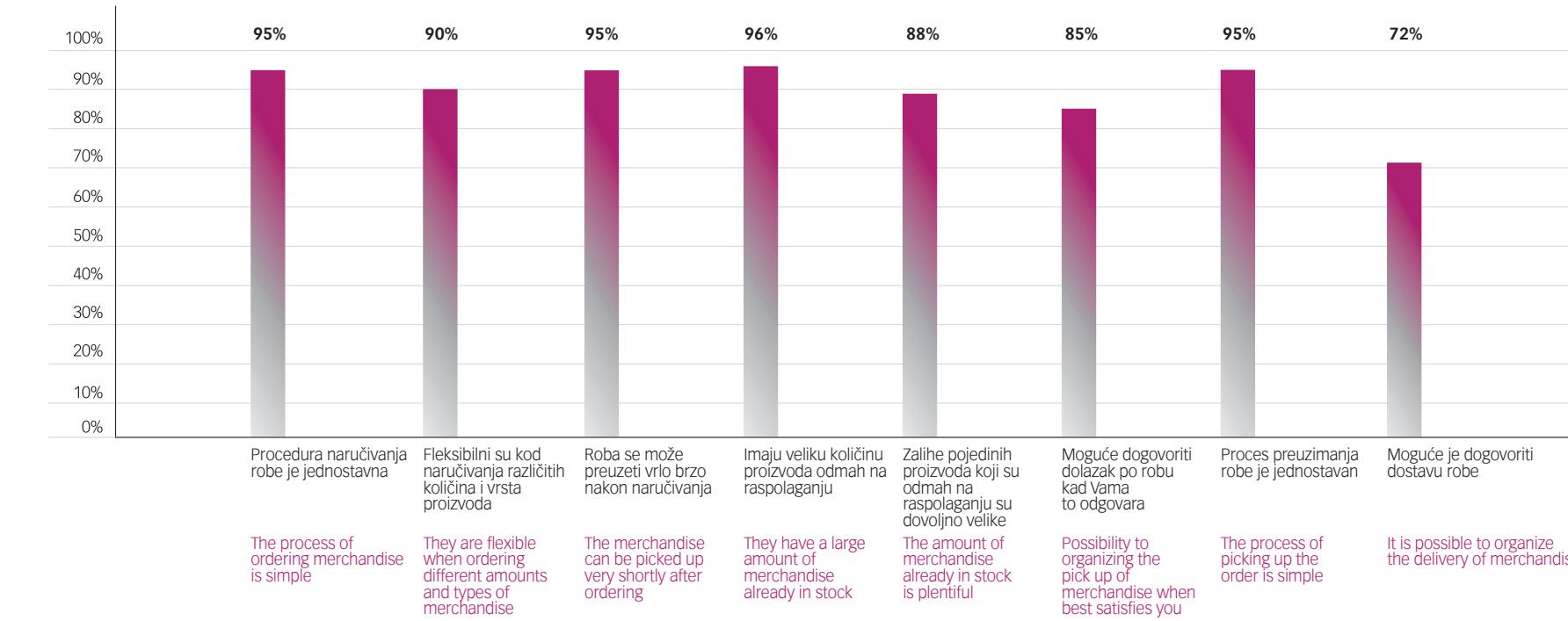

Zadovoljstvo specifičnim odrednicama poslovanja / Specific points of reference of satisfaction



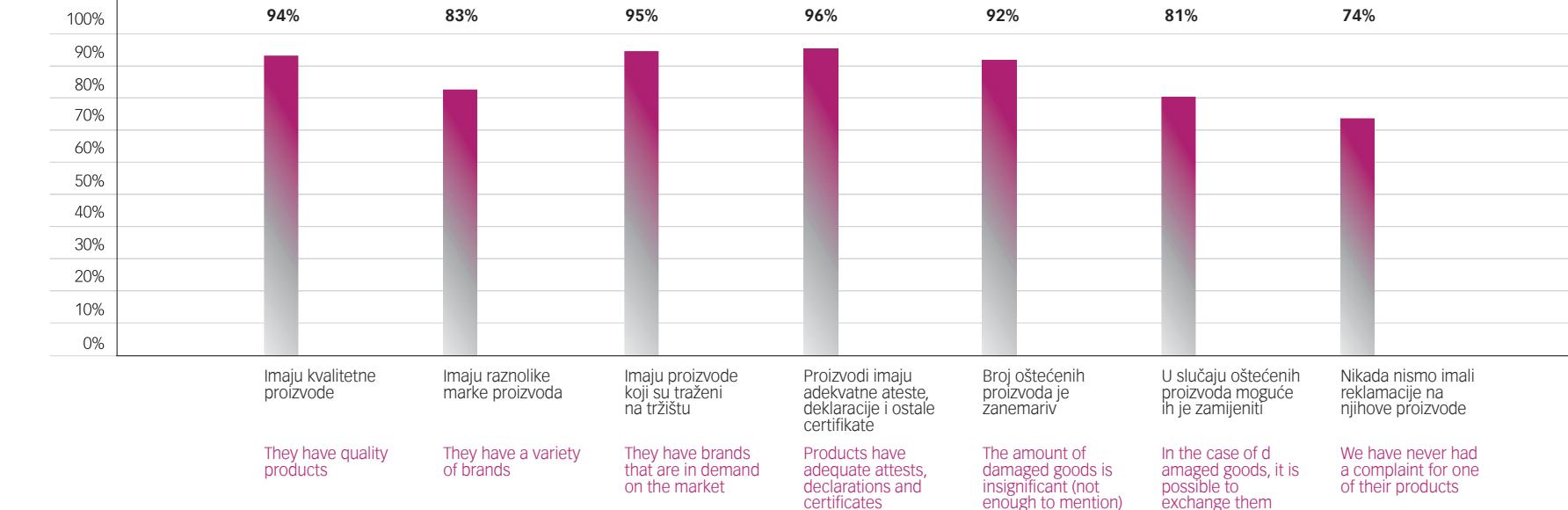

OPĆI PODACI

Tim Kabel društvo s ograničenom odgovornošću za trgovinu, Zagreb, Prijepolska 32 (u daljem tekstu: Tim Kabel) osnovano je 14. kolovoza 1991. godine. Društvo je upisano u Registar Trgovačkog suda u Zagrebu pod matičnim brojem subjekta 080163024. Temeljni kapital Društva iznosi 15.000.000 kuna.

GENERAL DATA

"Tim Kabel" is a limited liability company for trading, Zagreb, Prijepolska 32 (hereinafter: Tim Kabel) founded on 14 August 1991. The Company has been registered in the Registry of the Commercial Court in Zagreb under personal ID number of the subject of 080163024. Share capital of the Company amounts to HRK 15,000,000.

Tim Kabel has been register to perform the following activities:

TEMELJ ZA SASTAVLJANJE FINANCIJSKIH IZVJEŠĆA

Svete u finansijskim izvješćima jednake su svotama prikazanim u finansijskim izvješćima Tim Kabela. Izvješća su sastavljena prema zakonskim propisima uz primjenu usvojenih računovodstvenih politika.

POČETNA STANJA ZA 2007. GODINU

Poslovna godina jednaka je kalendarskoj godini. Godina za koju se obavlja revizija temeljnih finansijskih izvješća završava 31. prosinca 2007. godine. Revizija finansijskih izvješća za 2006. godinu obavljena je od strane revizorske tvrtke, te su početna stanja za 2007. godinu preuzeta iz revidirane Bilance za 2006. godinu. Početna stanja u Bilanci za 2007. godinu odgovaraju završenim stanjima Bilance za 2006. godinu.

TEMELJNE RAČUNOVODSTVENE POLITIKE

Temeljne računovodstvene politike primijenjene kod sastavljanja godišnjih izvješća za 2007. godinu suglasne su Međunarodnim računovodstvenim standardima te nisu mijenjane u odnosu na primijenjene u 2006. godini.

PRIHODI OD PRODAJE

Računovodstveni postupci za priznavanje prihoda temelje se, sukladno čl. 18. Zakona o računovodstvu, na Međunarodnom računovodstvenom standardu 18 - Prihodi. Prihodi se evidentiraju po fakturnoj vrijednosti za prodaju robe i usluge izvršene kupcima u obračunskom razdoblju, umanjenoj za iskazane trgovačke popuste i rabate. Vrijednosno uskladenje potraživanja, za koja je prema prosudbi Uprave ocijenjena neizvjesnost u naplati, umanjuje prihode tekućeg razdoblja.

MANAGEMENT OF THE COMPANY

The only member of the management who represents the Company and leads the operations individually and autonomously is Mr. Ivan Topčić, director.

BASE FOR PREPARING FINANCIAL STATEMENTS

The amounts in financial statements at the pages 3 through 7 are equal to the amounts presented in financial statements of Tim Kabel. The reports were prepared according to the law regulations with the application of adopted accounting policies.

INITIAL BALANCE SHEETS FOR THE YEAR OF 2007

A business year is equal to the calendar year. The year for which the audit of the elementary financial statements is performed ends on 31 December 2007. The audit of the financial statements for the year of 2006 was performed by our audit firm and the initial balance sheet for the year of 2007 was taken over from the audited Balance Sheet for the year of 2006. The initial states in the Balance Sheet for the year of 2007 correspond to the year-end Balance sheet for the year of 2006.

BASIC ACCOUNTING POLICIES

The basic accounting policies applied with the preparing of the annual statements for the year of 2007 are in conformity with the International Accounting Standards and have not been changed as compared to those applied in the year of 2006.

INCOME FROM THE SALES

The accounting procedures for the recognition of the income are based, in accordance with Article 18 of the Accounting Act, on the International Accounting Standard 18 - Revenue. The earnings are recorded at the value invoiced for the soled goods and services rendered to the customers in the accounting period, reduced by the declared commercial discounts and rebates. Value adjustment of the receivables for which the Management evaluated the uncertainty of collection reduces the income of the current period.

POSLOVNI RASHODI

Rashodi predstavljaju smanjenje ekonomske koristi tijekom obračunskog razdoblja u obliku odljeva ili smanjenja sredstva ili stvaranja obveza što za posljedicu ima smanjenje kapitala, ali ne ono u svezi s raspodjelom sudionicama u kapitalu (članovima društva).

Rashodi se priznaju u izravnom sučeljavanju s povezanim prihodima, koji proistječu iz istih transakcija i drugih događaja.

Troškovi prodane robe i obavljenih usluga sadrže troškove konverzije prodane robe i obavljenih usluga u odnosu na fakturiranu realizaciju po vrijednosti sukladno Međunarodnom računovodstvenom standardu 2 - Zalihe. Troškovi se iskazuju u razdoblju u kojem su nastali na temelju uredne knjigovodstvene dokumentacije.

Troškovi materijala i usluga tekućeg i investicijskog održavanja terete prihode obračunskog razdoblja.

PRIHODI OD KAMATA I KAMATE KAO RASHOD

Za nepravovremenu naplatu potraživanja od kupaca po osnovu prodaje obračunavaju se kamate u visini zakonske zatezne kamate. Kamate po danim kreditima obračunavaju se sukladno ugovoru.

Kamate po osnovu tekućih obveza obračunavaju se do kraja obračunskog razdoblja i iskazuju se kao rashod u obračunskom razdoblju na koje se odnose.

TEČAJNE RAZLIKE

Tečajne razlike koje se obračunavaju s temelja izvoza i uvoza za tudi račun te temeljem ugovora s valutnom klauzulom iskazuju se u korist ili na teret prihoda obračunskog razdoblja za koje su obračunane.

DUGOTRAJNA IMOVINA

Dugotrajna materijalna imovina evidentira se po troškovima nabave prema računu dobavljača uvećanim za troškove dopreme, montaže i sl., koji su nastali do stavljanja u uporabu sukladno Međunarodnom računovodstvenom standardu 16 - Nekretnine, postrojenja i oprema.

Stvari i oprema evidentiraju se kao dugotrajna imovina ako je vijek uporabe dulji od jedne godine i pojedinačna vrijednost veća od 2.000 kuna te se amortiziraju tijekom procijenjenog vijeka trajanja.

Pozitivna razlika nastala prodajom dugotrajne imovine iskazuje se kao prihod, dok se neotpisana vrijednost otudene i rashodovane dugotrajne imovine iskazuje kao rashod.

OPERATING CHARGES

Charges represent the reduction of economic benefit during the accounting period in the form of the outflow or reduced resources or of the creation of the liabilities what has the consequence of the reduction in capital, but not that one that is related to the distribution to the participants in capital (the members of the Company).

Charges are recognised in a direct confrontation with related income, which arise from the same transactions and other events. The charges of the sold goods and performed services contain the costs of the conversion of the goods sold in relation to the invoiced sales at the value in accordance with the International Accounting Standard 2 - Inventories. The charges are declared in the period in which they were created on the base of orderly bookkeeping documents. Costs of materials and the services of current investment maintenance charge the income of the accounting period.

RETURN ON INTEREST AND INTEREST AS A CHARGE

For untimely collection of the receivables from buyers based on sales the interest is calculated at the rate of a legal default interest. The interest for granted credits is computed in accordance with the contract. The interest based on current liabilities is calculated to the end of the accounting period and declared as the charges in the accounting period to which they refer.

EXCHANGE RATE DIFFERENTIALS

Exchange rate differentials are calculated based on the export and import for someone else's account and based on a contract with currency clause, they are declared in favour or at the charge of the income of the accounting period for which they were calculated.

FIXED ASSETS

Fixed tangible assets are recorded at the acquisition costs as per the supplier's invoice for the costs of delivery, assembly etc. that were created to the putting into use in line with the International Accounting Standard 16 - Property, Plant, Equipment.

The things and equipment are recorded as the fixed assets if the useful life is longer than one year and the individual value is larger than HRK 2.000 and if they are depreciated during the evaluated useful life.

A positive difference created through the sales of fixed assets is declared as the income, and the non-depreciated value of the alienated and written off fixed assets, is declared as the charge.

The things with the evaluated useful life up to one year or longer than one year and the individual acquisition value is smaller than HRK 2.000 are recorded as small inventory.

MONEY RESOURCES

Cash at the accounts with banks and at hand in cash box is declared at the nominal values.

Cash resources at the bank accounts, which are declared in foreign means of payment, are declared in HRK as converted at the mean rate of exchange of the Croatian National Bank as of the date of balancing.

KAPITAL

A current year profit or loss is declared as of the state on 31 December and carried forward to the next year.

LIABILITIES BASED ON GOODS AND SERVICES PROCUREMENT

Liabilities based on the goods and services purchase include all the liabilities based on the received goods and services and created up to the end of the accounting period. Liabilities based on the purchase of goods and services, liabilities to the employees and other liabilities are declared based on orderly bookkeeping documents on arisen liabilities. Liabilities in foreign means of payment based on the acquired goods and services are converted to the value in HRK at the mean rate of exchange of Croatian National Bank as of the date of balancing, and the exchange rate differentials are declared in Profit and Loss Account as a part of financial income or charges.

LONG-TERM LIABILITIES

Long-term liabilities are declared in business books at the value of the created business change based on an orderly document and the contract of the taking over of liabilities.
